FINAL FIELD ANNOUNCED FOR THE FIFTH ANNUAL STIFEL CHARITY CLASSIC

Field includes 20 of the top 25 in the Charles Schwab Cup standings, 37 PGA TOUR Champions major titles and three World Golf Hall of Fame members

ST. LOUIS (August 29, 2025) – Tournament officials announced today the final field for the fifth annual Stifel Charity Classic at Norwood Hills Country Club in St. Louis, Mo., scheduled for next week, Sept. 1–7. This elite roster of 78* players collectively represents 213 PGA TOUR Champions victories, including 37 senior major championship wins, 10 Charles Schwab Cup titles, and three World Golf Hall of Fame members, Ernie Els, Retief Goosen, and Bernhard Langer, the winningest player in PGA TOUR Champions history with 47 victories. The field also contains 20 of the top-25 players in the Charles Schwab Cup standings, including defending champion Y.E. Yang (No. 14), and fellow major winners Justin Leonard (No. 17), Els (No. 5), Retief Goosen (No. 10), and Stewart Cink (No. 2), who recorded his third PGA TOUR Champions win last week at The Ally Challenge presented by McLaren.

The field boasts 17 PGA TOUR major championship wins and includes three past champions of the Stifel Charity Classic competing in this year's tournament, David Toms (2021), Steve Flesch (2023), and Yang (2024).

Other notable entries include Stifel brand ambassador Billy Andrade, as well as PGA TOUR Champions rookies Søren Kjeldsen and Bo Van Pelt, who is a Compliance Solutions brand ambassador.

The Stifel Charity Classic is a Regular Season PGA TOUR Champions event in 2025, which will give way to the Charles Schwab Cup Playoffs—a season-ending, three-tournament series used to determine the TOUR’s season-long

champion. The 2025 PGA TOUR Champions schedule features 28 events and will conclude with the Charles Schwab Cup Championship in Phoenix, Arizona. The 2025 Season will have players competing for more than \$69 million in total prize money, the highest in PGA TOUR Champions' 45-season history.

All three rounds of Stifel Charity Classic presented by Compliance Solutions will be broadcast on Golf Channel.

Since its inception in 2020, the tournament has generated more than \$3.4 million in giving for charitable organizations.
