WORLD GOLF HALL OF FAME AND INTERNATIONAL AMBASSADOR OF GOLF GARY PLAYER TO HEADLINE 2025 LEGENDS LUNCHEON PRESENTED BY MISSOURI DIVISION OF TOURISM

Fifth annual Legends fundraiser kicks off 2025 tournament events
for the Stifel Charity Classic presented by Compliance Solutions

ST. LOUIS (July 17, 2025) – The Stifel Charity Classic presented by Compliance Solutions announced today that World Golf Hall of Fame member and the “International Ambassador of Golf” Gary Player will headline the tournament’s fifth annual Legends Luncheon presented by Missouri Division of Tourism at Norwood Hills Country Club on Wednesday, August 27, 2025.

This unique and inspiring event brings together sports legends and the community to benefit the tournament’s charity partners.

The 2025 Legends Luncheon will showcase Player sharing stories from his legendary career, which includes more than 150 professional titles, with nine major championships on both the PGA TOUR and PGA TOUR Champions counted among them.

Player is a South African professional golfer who is one of only six men in history to capture the career grand slam - winning all four of golf’s Major Championships. He was inducted into the World Golf Hall of Fame’s inaugural class in 1974, and during his career, Player won nine major championships on the PGA TOUR and nine majors on the senior tour. He is the only golfer in history to complete the career Grand Slam on both Tours.

Nicknamed the Black Knight, Mr. Fitness, and the International Ambassador of Golf, he is also a renowned golf course architect with hundreds of design projects throughout the world. Player has authored or co-written 37 books on golf instruction, design, philosophy, motivation and fitness. In 2016, he captained the South African Olympic Golf Team in Rio de Janeiro, Brazil. Player has received numerous accolades including the Laureus Lifetime Achievement Award, the PGA Tour's Lifetime Achievement Award, and was awarded the Presidential Medal of Freedom in the United States.

The 2025 Stifel Charity Classic will take place the week of September 1–7 at Norwood Hills Country Club.

The Stifel Charity Classic presented by Compliance Solutions has established a legacy of giving in the greater St. Louis region and beyond. Since its inception in 2020, the tournament has generated more than \$3.4 million in giving for charitable organizations.

The Stifel Charity Classic is a Regular Season PGA TOUR Champions event in 2025, which will give way to the Charles Schwab Cup Playoffs—a season-ending, three-tournament series used to determine the TOUR's season-long champion. The 2025 PGA TOUR Champions schedule features 28 events and will conclude with the Charles Schwab Cup Championship in Phoenix, Arizona. The 2025 Season will have players competing for more than \$69 million in total prize money, the highest in PGA TOUR Champions' 45-season history.

All three rounds of Stifel Charity Classic will be broadcast on Golf Channel.
