Stifel Charity Classic presented by Compliance Solutions becomes Charles Schwab Cup Playoffs event

SIXTH ANNUAL TOURNAMENT WILL BE CONTESTED THE WEEK OF OCTOBER 19-25, 2026, AS THE FIRST EVENT IN THE PGA TOUR CHAMPIONS SEASON-ENDING, THREE-TOURNAMENT SERIES TO DETERMINE THE TOUR'S SEASON-LONG CHAMPION

ST. LOUIS (September 2, 2025) – Tournament officials announced today the 2026 Stifel Charity Classic presented by Compliance Solutions will be a Charles Schwab Cup Playoff event and be contested the week of October 19-25 at Norwood Hills Country Club in St. Louis, Mo. The sixth annual tournament will be the first event in the PGA TOUR Champions season-ending, three-tournament series to determine the TOUR's season-long champion.

"We are honored that the Stifel Charity Classic has been elevated to a Charles Schwab Cup Playoff event," said Ron Kruszewski, Chairman and CEO of Stifel. "This milestone reflects the strength of our partnership with PGA TOUR Champions and our shared commitment to excellence, community impact, and the game of golf. St. Louis is a city known for both its support of professional sports and its generosity, and we're proud to host an event that embodies both."

The 2026 Charles Schwab Cup Playoffs will mark the 11th year for the PGA TOUR Champions culminating series. Past Charles Schwab Cup champions include World Golf Hall of Fame members Bernhard Langer (6), Tom Watson (2) and Missouri native Hale Irwin (2).

Before the start of the Playoffs, the season-long PGA TOUR Champions Money List is converted to the Charles Schwab Cup Points List. The top 72 players on the Charles Schwab Cup Points List at the end of the regular season (SAS Championship), will advance to the first Playoffs event, the Stifel Charity Classic presented by Compliance Solutions. The top 54 players on the Charles Schwab Cup Points List after the Stifel Charity Classic will advance to the second Playoffs event, the Simmons Bank Championship. From there, only the top 36 players advance to the season-ending Charles Schwab Cup Championship.

"The Charles Schwab Cup Playoffs have become such an integral part of PGA TOUR Champions, and we are excited to bring that intensity and drama to the Stifel Charity Classic starting in 2026," said PGA TOUR Champions President Miller Brady. "From day one, this event has delivered a best-in-class experience for our players, partners and fans. When you couple that with an incredible city like St. Louis, which is synonymous with postseason sports heroics across the board, you have a recipe for one of the best tournaments in our game."

The Stifel Charity Classic presented by Compliance Solutions proudly stands as a premier event on PGA TOUR Champions, but it is much more than a golf tournament. The event has established a tradition of giving in North St. Louis County and the greater St. Louis area. Since its inception in 2020, the Stifel Charity Classic has generated more than \$3.4 million in giving for charitable organizations.
