Stifel Charity Classic presented by Compliance Solutions announces new benefiting charity selection process

THREE CHARITY PARTNERS WILL BE DESIGNATED FOR 2026 –ALL SELECTED CHARITIES SERVE A ONE-YEAR TERM WITH THE ABILITY TO RE-APPLY AFTER TWO YEARS TO ALLOW THE TOURNAMENT TO BROADEN ITS IMPACT ON THE COMMUNITY

ST. LOUIS (August 4, 2026) – Officials of the Stifel Charity Classic presented by Compliance Solutions announced today the details surrounding the tournament’s new selection process to annually determine the benefiting charities of the official PGA TOUR Champions event.

The Stifel Charity Classic has established a tradition of giving in the St. Louis region and beyond that will be strengthened by the new process of determining three charity partners each year. All selected charities will serve a one-year term with the ability to re-apply after a two-year period, allowing the tournament to broaden its philanthropic impact in the community year over year by supporting nonprofit organizations that align with the charitable mission and community priorities of the Stifel Charity Classic.

Organizations applying for consideration must meet the tournament’s eligibility requirements, including holding a current and valid 501(c)(3) nonprofit status, based in the state of Missouri (or maintain a significant operational presence within the state), directly support and serve communities within the City of St. Louis, St. Louis County, or St. Charles County, and align with at least one of the Stifel Charity Classic’s charitable pillars (initiatives focused on military, youth, and youth financial literacy).

The application process is now open by visiting <https://www.stifelcharityclassic.com/charity/charity-application/> and will close on Friday, September 4, 2026.

Since its inception in 2020, the Stifel Charity Classic presented by Compliance Solutions has donated more than \$4.2 million to support charitable organizations in the St. Louis region and beyond.

The Stifel Charity Classic proudly stands as a premier playoff event on PGA TOUR Champions, but it is much more than a golf tournament. The events and activities associated with the Stifel Charity Classic provide an all-inclusive, entertaining atmosphere. The beautiful views of historic Norwood Hills Country Club serve as a backdrop for world-class golf and provide the perfect venue to mingle with friends, family and business leaders while watching some of golf’s greatest champions.

The 2026 PGA TOUR Champions regular season features 28 events (25 regular season and three playoff events) and will have players competing for more than \$70 million in total prize money, the highest in PGA TOUR Champions’ 46-season history. This year’s Charles Schwab Cup Playoffs, a season-ending, three-tournament series to determine the TOUR’s season-long champion, will mark the 10th year for the PGA TOUR Champions culminating series. The sixth annual Stifel Charity Classic will be the first playoff

event. Past Charles Schwab Cup champions include World Golf Hall of Fame members Bernhard Langer (6), Missouri natives Tom Watson (2) and Hale Irwin (2), and 2025 champion Stewart Cink.

The 2026 Stifel Charity Classic is October 19-25 at Norwood Hills Country Club.

The Stifel Charity Classic is open to spectators from Thursday, October 22 to Sunday, October 25 and ticket prices start at \$20.
